

**Regulations of the use of the Car Parts Catalogue published on the website [www.profiauto.pl](http://www.profiauto.pl)  
maintained by Moto-Profil sp. z o.o.**

**General provisions**

1. These Regulations define the rules of use of the **ProfiAuto Car Parts Catalogue** published on the website <https://katalog.profiauto.pl/>, hereinafter referred to as the “Catalogue”. Using the Catalogue is tantamount to reading and accepting these Regulations.
2. The Catalogue is administered by the Company MOTO-PROFIL Sp. z o.o. with its registered office in Chorzów, ul. Niedźwiedziniec 10, 41-506 Chorzów, entered in the Register of Entrepreneurs of the National Court Register kept by the District Court Katowice-Wschód in Katowice, 8th Commercial Division of the National Court Register under KRS number 0000025700, with share capital of PLN 4,006,000.00, NIP [Tax No.]: 9542022592, hereinafter referred to as “Moto-Profil”.
3. The term “User” used in the Regulations each time refers to a natural person, a legal person or an organisational unit without legal personality which is granted legal capacity under the separate laws that accepts these Regulations by checking the appropriate box during the first logging into the Catalogue. The User undertakes to comply with the generally applicable provisions of the law when using the Catalogue.
4. Moto-Profil takes the utmost care to protect the privacy of the Users of the Catalogue. All information provided by the Users is protected using appropriate information technologies in accordance with the currently applicable security standards.

**Copyrights, legal effects of publication in the Catalogue**

5. All rights, in particular author's economic rights to the content published in the Catalogue and to the entire Catalogue, including its text and graphic elements, sub-page layout and other elements, hereinafter referred to as the Work or Works, are vested in Moto-Profil or Catalogue data providers and are legally protected, in particular pursuant to the provisions of the Act of 4 February 1994 on Copyright and Related Rights (Journal of Laws 1994, No. 24, item 83, as amended) and the Act of 30 June 2000 – Industrial Property Law (Journal of Laws 2001, No. 49, item 508, as amended).
6. Using the Works published in the Catalogue is not tantamount to the acquisition of any rights to such Works by the User.
7. The User may use the Works published in the Catalogue by becoming familiar with them only as far as it is permitted by the applicable provisions of the law, in particular the provisions of the Act of 4 February 1994 on Copyright and Related Rights (Journal of Laws No. 24, item 83, as amended), the Act of 27 July 2001 on the Protection of Databases (Journal of Laws No. 128, item 1402) and the Act of 16 April 1993 on Combating Unfair Competition (Journal of Laws No. 47, item 211, as amended).
8. Unless otherwise expressly specified in the provisions of the Polish law, the User is prohibited to perform such actions as: copying, modifying, publishing by print or by electronic means, or transmitting in any way the entire Catalogue or its part without prior written consent of Moto-Profil.
9. The User cannot use programmes which automatically download or scan the content of the Catalogue without prior written consent of Moto-Profil.

10. The matters related to the conclusion of purchase-sales contracts when using the Catalogue are governed by the “General conditions of sales contracts performed by Moto-Profil sp. z o.o. with its registered office in Chorzów”, published on the website: [www.moto-profil.pl](http://www.moto-profil.pl).
11. The Catalogue consists *inter alia* of the **Catalogue Model**, which enables the User to find the right product based on the guidelines regarding the vehicle's make and model, and the **Offer Module**, which contains the list of available products without reference to the vehicle's make and model.
12. If Moto-Profil grants the User the right to supplement the Offer Module with **Additional Products** intended only for the customers of this User (**Special version of the ProfiAuto Parts Catalogue**), this User (hereinafter: **Special User**) is fully responsible for the content it publishes. Special User is authorised to supplement the content of the Catalogue in the manner referred to above, provided that it has all the required authorisations and approvals necessary for the use of graphic and text elements used in the Catalogue. In the event of any claims related to Additional Products raised by any private-law body or institution (national, international or any other organisation or public-law body), in particular with regard to copyrights, patent rights or other industrial property rights, as well as claims related to actions or omissions of third parties with regard to Additional Products for which Special User is responsible, whether before or after the conclusion of a sales contract, Special User shall indemnify Moto-Profil against all liability in this respect by voluntary performance of an obligation or by substituting Moto-Profil in initiated or pending judicial, arbitration or administrative proceedings, bearing the consequences of the decision issued, in particular with regard to the obligation arising from such a decision to pay of all principal and incidental dues specified therein.
13. Moto-Profil has the exclusive and unlimited right to modify any information published in the Catalogue, at any time, without prior notification of the users.
14. Moto-Profil deems all information published in the Catalogue as reliable and confirmed. However, Moto-Profil does not bear responsibility for the timeliness, accuracy and completeness of such information or for their usefulness for specific actions of individual Users. All actions taken by the Users based on such information are taken at their sole risk.

### **Personal data protection**

15. The User may view the Catalogue without the need to provide its personal data or to register.
16. In order to place an order, the User has to log in to the Catalogue. For this purpose, the User has to be a registered customer of Moto-Profil, logging in for the first time using the numbers: fiks, motonet and pin. The User is then allowed to log in again using its own login and password.
17. The registration is performed by completing the registration form and submitting it to the Moto-Profil customer service consultant.
18. The administrator of the User's personal data provided during the registration, who is responsible for their processing, is indicated in the registration form. Regulations concerning the processing of personal data by Moto-Profil are included in the Privacy Policy available at <https://moto-profil.pl/polityka-prywatnosci>.

### **Cookies**

19. Only to collect statistical data about user traffic and to facilitate the use of the Catalogue, Moto-Profil uses the technology known as cookies, i.e. information saved by the Catalogue in the User's computer (or another device with functions similar to those of a computer, allowing

to view the Catalogue) which the Catalogue can automatically read when connecting to this computer or device. The data collected by the Catalogue include in particular: IP address, domain name, browser type and operating system type. Such data may be collected by cookies and Google Analytics system. Regulations concerning the use of cookie technology are included in the Privacy Policy available at <https://moto-profil.pl/polityka-prywatnosci>.

### **Final provisions**

20. These Regulations come into force on 17.05.2018.
21. Moto-Profil reserves itself the right to modify the Regulations. The changes introduced will take effect upon the publication of the modified Regulations on the website: [www.profiauto.pl](http://www.profiauto.pl) available at <https://katalog.profiauto.pl>.
22. The rules specified in these Regulations are governed by the Polish law.
